Description by Chaley James

The post-graduate course on Victimology, Victim Assistance, and Criminal Justice has been held each May for more than three decades at the Inter University Centre Dubrovnik. The course brings together approximately 50-80 international students, and 30 internationally renowned experts from the field of victimology, criminology, and criminal justice. It covers the areas of the Theory and History of Victimology; UN Declarations and Victim Activities; Restorative Justice; Human Trafficking Victims; Victims in Various Criminal Justice Systems; Victimization of Women; Victim Compensation and Restitution; Crisis and Crisis Intervention; Refugees as victims; and much more. The interdisciplinary course provides students from around the world an opportunity to study current victimological issues, while building networks with scholars and fellow students. The instruction of the course is in English. Most years, there are thirty or more countries represented, spanning all regions of the world. The invited resource faculty prepare lectures based on their contemporary research and practices.

Course lectures from the 2024 course included content on Missing and Murdered Indigenous People in the U.S., Internally Displaced Victimization by Conflicts in Africa, The War in Ukraine, International War Tribunals, The Quebec's Special Tribunal for Sexual and Domestic Violence Victims, Family Violence in Israel, and Violence in the Balkans, among others.

The year 2022 marked the 36th anniversary of the Dubrovnik Course, returning after a two-year postponement as a result of the COVID-19 pandemic. The 2022 course was also significant in that it paid tribute to one of its founding members, Paul Paul Zvonimir Šeparović and a former long serving organizing co-director, Elmar Weitekamp. The Dubrovnik Course has proven to have become a tradition in our field and, arguably its greatest contribution, is the continued growth and strengthening of the connections it has created amongst past, current, and future victimologist. It is the people who attend the course and the work they share so passionately, which ultimately contribute to its success. Robert Peacock

• In an exchange of expertise, Prof Peacock participated in a Global Minds Programme that facilitated collaboration with KU Leuven (Katolieke Universiteit Leuven) in Belgium, a leading institution in law and criminology. This partnership, focusing on human rights, transitional justice, restorative justice and victimology, paved the way for impactful research on conflict, peace, and development. Prof Peacock was hosted for a period of two months (December 2023/January 2024) by Prof Stephan Parmentier from the Leuven Institute of Criminology (LINC). During this period Prof Peacock presented a joint seminar on the topic of "Victimology in Africa: Towards a new horizon" and amongst other activities participated in an international workshop on "Trauma-Informed Practices: how to improve the support to professionals in public settings?" at the Permanent Mission of Belgium to the European Union. This was done in close cooperation with LINC and the Belgium Ministry of Foreign Affairs in Brussels, together with an interdisciplinary project consortium, that included partners from Austria, Belgium, Croatia, Greece, Portugal, Slovakia, and Slovenia. A highlight of the of the exchange programme refers to the participation and celebration of justice and science in action when history was made in a trial that took place in Leuven of five high-level officials from Guatemala's military and political apparatus accused of murder, enforced disappearance and torture of Belgian missionaries in Guatemala forty years ago. With the sustained engagement of Prof Stephan Parmentier as the scientific advisor, the jury found the crimes grave enough to qualify as crimes against humanity, committed within the framework of "a generalised or systematic attack on the civilian population". Decades of perseverance, support and guidance testified to the impact of exemplary engaged scholarship with transnational reach, scope and value.



AFRICA

In Nigeria, women religious are rescuing, rehabilitating victims of human trafficking

• For decades, Nigeria has remained a source, transit and destination country for human trafficking in sub-Saharan Africa, with her citizens making up 6% of immigrants in Libya, where they are commonly traded in open markets, according to a 2021 report from the International Organization for Migration. Eight Latin American countries fighting human trafficking together Panama City

A United Nations Office on Drugs and Crime (UNODC) project, TRACK4TIP, is bringing countries in the region together to stand against this horrific crime, resulting in some 90 criminal investigations and the identification of more than 600 trafficking victims.
